Fund Manager Albrecht von Witzleben achieves again Citywire AAA Rating

Albrecht von Witzleben, fund manager of the Deutsche Aktien Total Return fund, has again received the 'AAA' rating from Citywire in the category 'Mixed Assets - Flexible EUR'. Out of 365 fund managers listed in the category only 40 obtained a rating, of which Albrecht von Witzleben was the only manager to obtain the 'AAA' rating.

The fund was launched on LRI Group UCITS Platform in June 2005 and has achieved assets of over EUR 380m to date.

Albrecht von Witzleben studied business administration at St. Gallen and during his career, worked for Dr Jens Ehrhardt and JP Morgan Asset Management, where he managed institutional mandates for US and European equities. In 1998, he launched Albrecht von Witzleben Asset Management and has been the lead fund manager of the Deutsche Aktien Total Return since 2005.

The fund strategy is geared towards long-term, sustainable asset growth. The fund assets are valued according to the principle of risk diversification and invested in German companies (securities), in particular in equities, corporate and convertible bonds. The process of an active, flexible investment strategy is pursued in order to achieve an absolutely positive, attractive return. Critical to the long-term investment success, aside from the selection of the investment priorities and their weighting under macroeconomic data and indicators, is the intensive fundamental selection of individual titles (stock picking). For an effective Portfolio-diversification, investment in secondaries ("mid- and small caps") is also necessary.
