TAO Alternatives Liquid Alternative Strategy exceeds EUR 500m on LRI UCITS Platform

LRI Group, the leading independent investment services company, in partnership with TAO Alternatives is pleased to announce the TAO Alternatives liquid alternative investment strategy has exceeded EUR 500m Assets under Management (AuM) by February 2018.

LRI Group announced the partnership with TAO Alternatives in September 2017 when the investment strategy was at EUR 250m AuM. The strategy has doubled in size in six months due to several big mandate wins from German pension funds and pension schemes. The investment strategy has also received increased interest from the UK and Switzerland markets.

The strategy is rather unique as it is highly diversified, aims to avoid tails risk by adding long volatility transactions and delivers consistent returns in the long-run.

Fund managers Achim Motamedi and Stefan Müller, commented:

"With a track record of more than ten years, this is one of the oldest risk premia absolute return strategies in the German-speaking world. Most fund concepts from other providers have only been around for a few years and have no track record that covers difficult periods such as the 2008/09 financial crisis."

"We are very pleased with how the investment strategy is growing. We've seen great interest from institutional investors across Europe, in particularly in Germany and we hope 2018 will be an even better year for us."
